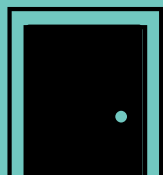


YOUR RIGHTS WITH IMMIGRATION

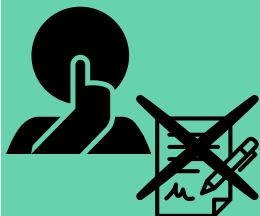
**IMMIGRATION & CUSTOMS ENFORCEMENT (ICE)
AND CUSTOMS & BORDER PROTECTION (CBP)**

YOU HAVE THE RIGHT NOT TO OPEN THE DOOR



COMMUNICATE THROUGH A WINDOW OR CLOSED DOOR.

ICE AND CBP AGENTS CAN ONLY ENTER YOUR HOME EITHER WITH YOUR CONSENT OR WITH A SEARCH WARRANT ISSUED BY A COURT AND SIGNED BY A JUDGE OR MAGISTRATE. (SEE BACK FOR EXAMPLE.)



YOU HAVE THE RIGHT TO REMAIN SILENT & NOT TO SIGN ANY DOCUMENT

YOU CAN SAY OUT LOUD THAT **YOU WILL NOT ANSWER QUESTIONS OR SIGN A DOCUMENT** WITHOUT AN ATTORNEY PRESENT.



YOU HAVE THE RIGHT NOT TO CONSENT TO A WARRANTLESS SEARCH

YOU HAVE THE RIGHT TO REFUSE THE AGENTS ENTRY TO YOUR HOME. AND **YOU HAVE A RIGHT TO REFUSE WARRANTLESS SEARCHES** OF YOUR BODY, YOUR CAR, OR YOUR HOME.



YOU HAVE THE RIGHT TO TAKE PHOTOS, VIDEOS, & WRITE DOWN DETAILS

YOU CAN INFORM THE AGENT THAT YOU ARE GOING TO USE YOUR **RIGHT TO RECORD**. (YOU MUST NOT INTERFERE WITH THE AGENTS' DUTIES OR THE SAFETY OF OTHERS.)

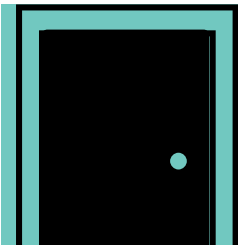

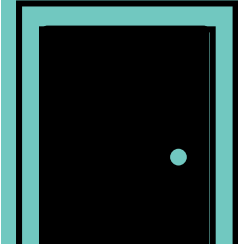

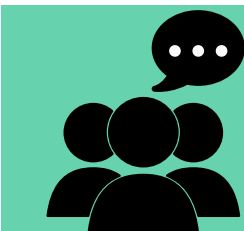
